DIRECTOR'S ORDER PURSUANT TO RULE 901.a.

This Order is issued by the Director of the Colorado Oil and Gas Conservation Commission ("COGCC" or "Commission") pursuant to Rule 901.a. of the Rules and Regulations of the Colorado Oil and Gas Conservation Commission, 2 CCR 404-1 ("Rule" or "Rules").

INTRODUCTION

- 1. Omimex Petroleum Inc. (Operator No. 66190) ("Omimex") is the operator of numerous oil and gas facilities, including the 339 Wells described in Exhibit A, which are located in Phillips and Yuma Counties.
- 2. As of April 13th, 2023, Omimex appears to have abandoned these facilities and is not actively responding to surface owner concerns or COGCC inspections.
- 3. The Director has reasonably ascertained the underlying facts on which this action is based. Therefore, the Director has objective grounds and reasonable cause to determine that Omimex, in the conduct of oil and gas operations, is impacting or threatening to impact public health, safety, welfare, the environment, and wildlife resources.
- 4. Specifically, the Director finds that Omimex has abandoned numerous oil and gas facilities which is resulting in actual impacts and the threat of impacts across these facilities. The Director finds that this situation requires immediate attention, and the Director enters this Order requiring Omimex to immediately cease production operations at all 339 Wells described in Exhibit A.
- 5. The Director will inspect and may take action to protect public health, safety, welfare, the environment, and wildlife resources, including shutting-in Omimex's wells, until Omimex has come back into compliance with all COGCC Rules.
- 6. No wells or facilities described in Exhibit A will be returned to production until the COGCC has re-inspected and determined that the ongoing threat to public health, safety, welfare, the



environment, and wildlife resources has been fully addressed and that Omimex is sufficiently staffed to return these wells to production.

BACKGROUND

- 7. Omimex has owned and operated numerous oil and gas facilities since 1997.
- 8. These facilities currently include 339 Active Wells.
- 9. Since mid-2022, Omimex has demonstrated systemic non-compliance and unresponsiveness which indicates an unwillingness, or inability to, comply with COGCC Rules.
- 10. For example, Omimex has failed to file Form 7, Operator's Monthly Report of Operations for these wells since mid-2022, as required by Rule 413.
- 11. Additionally, pursuant to Rule 605, operators are required to include on facility signage a telephone number at which the operator can be reached at all times. All signage at the Omimex locations visited by Commission Staff on April 6th through April 10th list an emergency contact number that, when called, is not working, violating Rule 605 (including but not limited to Doc. Nos. 701603069, 701603070, 701603078, 693600777, 693600775, 693600779).
- 12. On March 8, 2022, the Commission received a citizen complaint indicating that Omimex failed to pay production proceeds to a royalty owner. Doc. No. 402976508. The complaint alleges that Omimex failed to make royalty payments dating back to 2018, and that Omimex failed to respond to inquiries regarding the missing payments. This complaint did not result in a payment of proceeds action.
- 13. Similarly, on June 15, 2022, the Commission required Omimex to pay production proceeds owed to a royalty owner. See Order No. 1-270. In its Order, the Commission found that Omimex was unresponsive to COGCC Hearings Staff as well as unresponsive to the Applicant. See id. Despite due notice, Omimex filed no answer or responsive pleadings of any kind and was ordered to pay \$44,104.94 and additional interest in production proceeds. See id. To date, the Applicant has received roughly half of the owed production proceeds, paid in June 2022. Applicant stated to Staff on April 13, 2023, they will seek the unrecovered amount likely via civil action, and that they have had little to no response from Omimex since June 2022.
- 14. Similarly, Enforcement Staff has received minimal to no response from the operator electronically in regard to emergency contact information, Rule requirements, or Financial Assurance concerns over the last few months. A responsive email was returned from a listed COGIS contact for Omimex on April 7, 2023, indicating that he was a contractor working for Omimex and has since left employment due to nonpayment. Other COGIS contact emails bounce back as invalid or no longer in operation. Staff reached out to former counsel for Omimex who in turn indicated he was no longer retained by the company.
- 15. Each of these incidents, and those that follow, indicate a complete lack of presence by Omimex in actively engaging with the public, Commission Staff or in the proper operation of its oil and gas facilities.

- 16. Staff, acting on another citizen complaint dated March 27, 2023 (Doc. No. 402995917), inspected several of Omimex's locations and found what appears to be Omimex's abandonment of multiple facilities. The complaint alleges many deeply concerning issues including that four out of six gas wells that had leaks in the meter sheds were so bad they could smell them a half of a mile away at their house. Further, they allege they had not received royalty checks in a year and a half. The complainant's brother shut the wells in, citing a safety concern.
- 17. On April 6, 2023, Commission Staff conducted an inspection of Location 314031. Doc. No. 701903073. Staff observed improper signage and noted the late Form 7s described above. Additionally, Staff observed an open valve at the wellhead and the flowline, resulting in a release of natural gas and produced water. Moreover, Staff observed severe corrosion on the piping and valve as well as an uncalibrated gas meter. In its Field Inspection Report ("FIR"), Staff cited violations of numerous Rules, including Rules 912.a., 912.b., 905.c., 906, and 430.d. Because no Omimex personnel or contractors were on site and the listed emergency contact number was inoperable, Commission Staff was forced to shut-in the well to protect public health, safety, welfare, the environment, and wildlife resources.
- 18. Additionally on April 6, 2023, Commission Staff inspected Location 314036. Doc No. 701603072. During this inspection, Staff observed that the signage was laying down and included an invalid emergency contact number. Staff also observed a wellhead valve partially open and releasing natural gas into the atmosphere and cited an immediate need to remove, remediate, and dispose of lube oil and stained/saturated soils at the wellhead and adjacent area. COGCC Staff took emergency action and closed the valve leaking natural gas to protect health, safety, welfare, the environment, and wildlife resources. Additionally, Staff observed debris around the location and adjacent area.
- 19. On April 7, 2023, Commission Staff inspected Location 314030, and found it to be in a similar state as Location 314031. Doc. No. 701603074. Commission Staff noted an open valve leaking natural gas. Again, Commission Staff was forced to take emergency action and close the valve to protect public health, safety, welfare, the environment, and wildlife resources. Commission Staff also observed stained soil at the wellhead and around the pad necessitating removal, remediation, and disposal in compliance with the 900-Series Rules. Commission Staff observed debris around the wellhead in violation of the 600-Series Rules.
- 20. The spills or releases listed above pose an ongoing threat to groundwater and air quality.
- 21. On April 10, 2023, Commission Staff inspected Location 338254 and noted several violations. Doc. No. 693600785. During this inspection, Staff observed a chemical tank lacking proper containment. Again, as previously noted, signage linked to an invalid emergency contact number.
- 22. A consistent pattern of these same or similar violations described above are noted in additional Commission Staff FIR Doc. Nos: 701603070, 701603069, 701603071 for various other locations.

- 23. On April 10, 2023, Commission Staff inspected Location 314122. During this inspection, Staff observed the valve of a Flowline broken underground near the wellhead and actively leaking gas. Doc. No. 693600783. In light of the active gas leak and nonfunctioning emergency contact number, Staff was forced to take emergency action and close the valve in order to protect public health, safety, welfare, the environment, and wildlife resources. Additionally, Staff observed that the 210-barrel water tank on site had a missing hatch, requiring either replacement or wildlife netting to properly protect against wildlife incursions or potential safety risks. Both of these violations would be easily identifiable with proper and required monitoring by Omimex. Moreover, the charting had not been changed since January 2023 indicating the possibility that the location had not been visited in months.
- 24. Late charting was noted throughout many other contemporary inspections.
- 25. On April 10, 2023, Commission Staff inspected Location 336747 and found another broken flowline that required Commission Staff to do an emergency shut-in of the well. Staff noted the flowline likely froze and broke. FIR Doc No. 693600787. As before, Staff shut-in the well after finding there was an active gas leak on the flowline. This inspection noted that there were two leaks on the same flowline, one outside the meter shed at a T-Junction and one inside the meter shed. Again, Omimex could not be contacted. Similar to Staff's observations at Location 314122, Staff observed that the water tank had a missing hatch, requiring either replacement or wildlife netting to properly protect against wildlife incursions or potential safety risks..
- 26. Staff further noted on all of the recent inspections described above that the lease road had minimal to no signs of tracks, indicating the strong likelihood these sites had not been visited recently. Coupled with the state of these locations and the active leaks documented at multiple locations, it is reasonable to assume that Omimex has abandoned and/or not been regularly monitoring these locations at all. This neglect poses an immediate and imminent risk to public health, safety, welfare, the environment, and wildlife resources.
- 27. Citing numerous failures to monitor and meet COGCC reporting standards, and failures to timely submit regulatory reports, COGCC Enforcement Staff applied for a hearing on April 11, 2023 in Docket No. 230400121. The three Notices of Alleged Violation that are the subject of the application include violations of requirements to timely file financial assurance information, operator registration, and perform annual bradenhead tests. Each of these requirements are regularly performed by most operators in the State of Colorado, and the failure to file these documents and perform these tests implicates public health, safety, welfare, the environment, and wildlife resources. In its hearing application, Commission Staff requests relief from the Commission including potentially the revocation of Omimex's Form 1 and the claiming of Omimex's financial assurance.
- 28. Following a full investigation of these matters, the Director has objective grounds and reasonable cause to determine that Omimex, in the conduct of Oil and Gas Operations, is impacting and threatening to impact public health, safety, welfare, the environment, and wildlife resources, by failing to report, regularly monitor, update, investigate, clean up, and document

impacts resulting from oil and gas operations and failing to implement measures to prevent the recurrence of non-compliance at the 339 wells described in Exhibit A.

- 29. Moreover, based on Omimex's actions and inactions described above, the Director has objective grounds and reasonable cause to determine that a suspension of operations is necessary at the 339 wells described in Exhibit A to ensure that public health, safety, welfare, the environment, and wildlife resources are protected.
- 30. Omimex's actions and inactions are currently impacting or threatening to impact public health, safety, welfare, the environment, or wildlife resources requiring action by the Director to avoid, minimize, or mitigate those impacts or threatened impacts.
- 31. Therefore, the Director hereby requires Omimex to take the following actions to avoid, minimize, or mitigate the potential impacts to public health, safety, welfare, the environment, or wildlife resources.

ORDER

In accordance with Rule 901.a., the Director ORDERS that Omimex immediately cease all production operations at each of the 339 wells described in Exhibit A.

This Order will remain in effect until such time as Omimex has come back into compliance with all COGCC Rules; including, but not limited to, those instances of non-compliance described above.

No wells or related facilities described in Exhibit A will be returned to production until the COGCC has re-inspected and determined that the ongoing threat to public health, safety, welfare, the environment, or wildlife resources has been fully addressed and until the COGCC has determined that Omimex is sufficiently staffed to return these wells to production.

All questions regarding the Order, and the steps Omimex must take to return to compliance with COGCC Rules, as required by this Order, should be directed to Mike Leonard, Compliance Manager.

The provisions contained in the above Order shall become effective immediately. If Omimex does not comply with the Order, the Director may take action to assess, shut-in, plug and abandon and/or remediate the wells described in Exhibit A and seek costs pursuant to C.R.S. § 34-60-124.

The Director expressly reserves the right to alter, amend, or repeal any and/or all of the above orders.


